Teacher Recommendations

Students will need to have one teacher recommendation, to be sent to Prairie Plains Resource Institute by email or mailed to our office by the teacher. Students must request a recommendation from a teacher they have had during the current (2017-2018) school year. It is the student’s responsibility to see that a teacher writing a recommendation has the appropriate information to turn in their recommendation. (It may be best to print a copy of this application to give the teacher writing the recommendation so that they have the details.) **The deadline for receiving teacher recommendations is the same date that student applications are due: April 27, 2018.** A teacher recommendation should be brief (1-2 paragraphs) and should describe a student’s character. Teachers should email or mail in the completed recommendation and include the student’s full name. Please email or mail in recommendations to the Youth Naturalist Program coordinator, Sarah Bailey.

Financial Assistance: Student Scholarships Available

Financial assistance is available to students that qualify. Scholarships will help cover the registration fee of the program. We are working with the Hamilton Community Foundation and the Merrick Foundation to provide scholarship funding to students from Hamilton County and Merrick County.
